Eritrea

Eritrea continues to imprison conscientious objectors. There is no available recent information on the situation of the conscientious objectors listed below, who have not been charged. The below are all Jehovah's Witness, imprisoned for conscientious objection to military service.

Eritrea's military service is indefinite, for men and women, and starts in the final two years of high school, which is in a military camp.

Turkmenistan

In Turkmenistan, nine conscientious objectors are known to be in prison, six of them jailed in 2019. Military service is compulsory for men between 18 and 27, and it is generally two years. Despite repeated calls by the United Nations, the Turkmenistan state doesn't offer any civilian alternative to military service.

Israel

In November and December some draft refusers in Israel are likely to be going to prison. Their prison sentences will be short—10, 20 or 30 days long—so it is not worth us adding them to this list, since by the time you receive it they may be out of jail.

Korea, South

Despite the positive news we received from South Korea in 2018 -Constitutional Court and Supreme Court decisions in June and October respectively, and release of tens of conscientious objectors-South Korea continued to imprison conscientious objectors In 2019. Below you can find the information of two of the conscientious objectors who are now behind bars.

Seven peace activists face 25 years in prison for their protest actions on the Kings Bay nuclear submarine base in Georgia, on April 4, 2018. On October 24, 2019, they were found guilty and charged with a range of crimes, including trespassing, depredation of government property.

Singapore

Singapore does not recognise the right to conscientious objection. Conscientious objectors usually serve two terms in prison, the first up to 15 months and the second

up to 24 months - which means that they can serve up to 39 months behind bars.

Sending cards and letters

- Send your card in an envelope;
- Include a return name and address on the envelope;
- Be chatty and creative: send photos from your life or drawings;
- · Let the prisoners know what you are doing to stop war and war preparations;
- Don't write anything that might get the prisoner into trouble;
- Think about the sort of thing you'd like to receive if you were in prison;
- Try not to begin your correspondence with "You are so brave, I could never do what you have done";
- · Remember that the prisoner may not be able to reply.
